1. Introductory remarks:

Lord Best updated Members and other interested parties on the APPG's work since the Group's Inaugural Meeting in October 2024.

These updates covered:

- A meeting held in November 2024 with Fiona MacGregor, Chief Executive of the Regulator of Social Housing (RSH), which included discussion of the Charter for Disposal of Supported Housing and Accommodation for Older People in the APPG's 2024 report on 'The Regeneration of Outdated Sheltered Housing'.
- A letter Lord Best wrote to the Health and Safety Executive (HSE) in January 2025 to inquire about the timetable for launching the consultation on the M4(2) accessibility standard.
- A meeting on older people's housing held in February 2025 with civil servants from the Ministry of Housing, Local Government and Communities (MHCLG) currently working on the government's national Housing Strategy. Attendees were informed that presentations were given by Professor Julienne Meyer (Older People's Housing Taskforce) and other experts.
- A breakfast discussion session on older people's housing for MPs held in February 2025, sponsored by Anchor. Attendees were informed that presentations were given by Les Mayhew (Professor of Statistics, City St George's, University of London) and other experts.

2. Launch of APPG's new Inquiry: 'Creating Intergenerational Communities':

Anna Dixon MP and Lord Best informed Members and other interested parties that the APPG has launched a new Inquiry on 'Creating Intergenerational Communities'.

The Co-Chairs thanked The Riverside Group and Places for People for agreeing to sponsor the Inquiry. Attendees were informed that the Housing Learning and Improvement Network (Housing LIN) would act as the Inquiry's Secretariat.

Presentations by guest speakers followed:

- Charlotte Miller provided an overview of Intergenerational England's approach to intergenerational issues and their relation to housing.
- Sally Nichols discussed examples of Riverside's intergenerational extra care living schemes.

- Rachel Crownshaw discussed Places for People's scheme at Gilston Park.
- Michael Voges covered examples of intergenerational approaches to integrated retirement communities.
- Lois Beech outlined the broad plan for the Inquiry and explained Housing LIN's Secretariat role.

It was explained that the APPG would be assisted by a panel comprising Parliamentarians and specialists with backgrounds in the private and social housing sectors, design and planning. It was also noted that evidence would be collected by inviting expert witnesses to the Inquiry's panel meetings, and that submissions would be welcome from interested parties.

Members of the APPG Inquiry panel in attendance introduced themselves.

3. Discussion:

Following the presentations, Anna Dixon chaired a discussion. Attendees offered comments and asked questions.

4. Concluding remarks:

It was noted that a final report of the APPG's Inquiry would be published in 2026.
