	Response
	As from 25 February 2025, a new Procurement regime, called the Procurement Act 2023 comes into force. So we would like to draw your attention to new Government registration requirements for anyone who tenders regularly to register on a new Central Digital Platform (CDP), prior to tendering on any E Tendering platform, including Delta E Sourcing.
	You will be required to register and provide basic company information to the CDP and once registered, you will receive a 'company identifier code' that you then use when you tender hey bid for Housing 21 tenders via Delta E Sourcing. The code acts as a link to key information on the CDP, which will be 'pulled through' to any bids you submit, aiming to reduce time for you (suppliers), duplicating information
